1. This Invitation for Tenders follows the General Procurement Notice for this Project which appeared in Uhuru, Majira and Daily newspapers Issue no. SSN 0856-3812 dated 15th August, 2008
2. The Government of Tanzania has set aside funds for the operation of the Ministry of Agriculture Food Security and Cooperatives during the financial year 2008/2009. It is intended that, part of the proceeds of the fund will be used to cover eligible payment under the contract for the provision of **Security Services**.
3. The Ministry of Agriculture Food Security and Cooperatives now invites sealed tenders from eligible National providers of **Security Services**.

Tendering will be conducted through the National Competitive Tendering procedures specified in the Public Procurement (Goods, Works, Non-Consultant Service and Disposal of Public Assets by Tender) Regulations, 2005 - Government Notice No. 97 and is open to all Tenderers as defined in the Regulations.

A complete set of Tendering Document(s) in English and additional sets may be purchased by interested Tenderers on the submission of a written application to the address given under paragraph 5 above and upon payment of a non-refundable fee of **Tanzania Shillings Fifty thousands, (50,000.00 TAS)**. Payment should either be by Cash, Banker's Draft, or Banker's Cheque, payable to Permanent Secretary Ministry of Agriculture Food Security and Cooperatives.
 7. All Tenders must be accompanied by a Tender Security Declaration.
 8. All tenders in one original plus three copies, properly filled in, and enclosed in plain envelopes must be delivered to the address below at or before **09.00 am Local Time on Wednesday 25th , February, 2009**. Tenders will be opened promptly thereafter in public and in the presence of Tenderers' representatives who choose to attend in the opening at the Kilimo Road, Kilimo 1 Building, 2nd Floor, Conference Room, Dar es Salaam.
 9. Late tenders, portion of tenders, electronic tenders, tenders not received, and not opened and not read out in public at the Tender opening ceremony shall not be accepted for evaluation irrespective of the circumstances.
